### Treasurers Report for the year ending 31 May 2019

Residents have not been asked to pay any further subscriptions for the past two years as agreed at the AGM held in 2017. As the two years are now up, the situation needs to be reviewed. #### Income

There has been no income for 2018/19.

#### **Expenditure**

Expenditure this year included the cost of a gift for Mrs Broadhurst for the use of the nursery for the 2018 AGM (£10.50), and the cost of maintenance of the website for 2017/18 (£89.45) – the invoice was received after the end of the financial year and was therefore paid in this financial year. Total expenditure for 2017/18 amounted to £99.95

#### Assets

Expenditure (£99.95) was more than income (£00.00) for 2018/19 leaving a deficit of £99.95 However taking into account the reserves from 2017/18 (£5881.51,) the amount in the bank to take forward against future expenditure for the next financial year is £5781.56.
